Highlighted first PhD degree in Environmental Studies; Cyber Security program is entering accreditation review, School of Engineering and program of Engineering Technology merged to form the School of Engineering and Technology and Rafael Obregon will serve as Interim Director; pathway agreement with Highland Community College takes students from high school to Highland to WIU in four years to earn a bachelor's degree in Early Childhood Education; Marching Leathernecks were invited to play at the Pearl Harbor Memorial Parade in Honolulu, HI; IIRA has worked with legislators for economic development with the PTAC positions and a rural grocery store initiative; awarded 742 undergraduate degrees, 272 master's degrees and 3 doctoral degrees.
