WIU has been recognized as Tree Campus USA and has been since 2012. Chair Radosh asked if we could rectify flat roofs on campus due to maintenance costs. AVP Rhoads said that the flat roofs are more economical if maintenance is not deferred.

The biggest facility concerns are building envelope issues, masonry surfaces, aging mechanical systems. Trustee Radosh expressed appreciation for the facilities facelift as it aids in recruitment and morale.

Dr. Ilon Lauer - Chair, Faculty Senate - Macomb

The Senate held its first meeting last week and are working on restructuring. Trustee Stutz asked what is Dr. Lauer's viewpoint on the student to faculty ratio. He said that he believes that 22:1 is a bit high and some things may be lost and focus on a particular number may also distract from what is important. More faculty = more courses and a broader experience.

Meet with constituents across campus and goals are professional development and open lines of communication.

Nicky Friedrichsen – President, Civil Service Employees Council

Reported on the frustrations of Civil Service employees and their request for a salary increase.

We are at roughly 30% online classes, similar to where we were this time last year. Students overwhelmingly want to be in person.

Vice President for Student Success, Dr. David Braverman report highlights are as follows:

Dr. Braverman has been immersing in campus life, meeting students, enjoying the beginning of the semester. Staff are coming together to support the pandemic fight. Student organizations are active and though the activities look different they are happening.

Trustee Twomey asked what the plan is with noncompliance with testing or vaccination. Dr. Braverman said that there will be letters of concern issued to those who have not complied.
