PUBLIC COMMENTS

Patrick McGinty - Raised concern that the resolution voted on later today to raise or increase salaries is more of a restitution of salaries. Inflation has continued to increase far faster than salaries.

Concerns expressed for the ongoing problems of understaffing and overworked individuals while University expenses continue to increase. Request that WIU take a look at fixing fiscal responsibility in 2023 and invest in the University's faculty.

Mark Benards - The 2% raise is greatly appreciated. Review of last several years raises and cuts within the University. Expect the Administration to engage in a collaborative bargaining process with the Union. Request to increase salaries more in order to help staff and faculty.

CHAIRPERSON'S REMARKS

Thank you to our faculty and staff, the trustees who attended, and the Vice Chair Dolieslager for representing the board during graduation.

Thank you to President Huang for his leadership. Thank you for creating the Anti-Racism Taskforce.

Thank you to the Board of Trustees for their volunteerism.

Thank you to the men's and women's basketball team and hope to meet with more athletic teams soon.

If there is anything you would like one of the trustees to see, please bring it to us. We now have offices on the Quad City Campus and Macomb campus.

Trustee Tiemann gave a short thank you to the board and all she has worked with.

PRESIDENT'S REMARKS

President Huang - Thank you to everyone who has attended today and all of the Board of Trustees for their service.

Updates given on five priorities.

Enrollment, retention and recruitment- Enrollment is still too early to tell but it looks like we will be even or a little up this fall. Recruitment numbers do not yet include International students. Randy Glean is doing a fine job in recruiting and he will continue to work on this initiative. Recruitment is a priority and the team is working very hard. Retention is important and we need to look at graduating students in 4 to 5 years. Even a small increase is still an increase. We will work hard because we are anticipating the upcoming 2026 enrollment cliff.

DEI - We stood up at the Anti-Racism Taskforce. This is the first Anti-Racism Taskforce this university has ever had and this is real progress. We have seen some good work coming from this group already and we will continue to work towards a diversity plan that is appropriate for WIU's culture. We have started a search for a JIDE Director (Justice, Inclusion, Diversity and Equity). We hope to have this person in place late this summer or early fall.

Institutional Distinctiveness - A report has been completed and the committee has been discussing this initiative. This will help make us more distinctive and more attractive to students and parents. We will include academic programs as well as non-academic programs.

Financial Sustainability - WIU does have challenges. I'm comfortable telling you that we are not there yet. I am hopeful. I recognize that the salary increase is not large but I do want the record to show that there was a retroactive increase going back to July 2021. For the last few years we have been stable but we need to be better. We need to increase our enrollment which is a national challenge. Second, we need support from the state. There is a 5% increase but it still is not enough. There is a task force working very hard to produce a financial sustainability plan.

Senior Leadership Building - We have hired a new Provost, Dr. Zoghi. He will start on July 1st. I look forward to working with him. We also brought forward a new Interim Vice President of Advancement and Alumni Relations. This will reflect the focus of that division on fundraising and engaging alumni. Mr. Mike Murtagh will be joining us soon and he has great experience in raising money. He will start working towards the Campaign.

There has been a lot of interest in the AD position. I hope to make a decision soon.

Juneteenth is coming up and we are very excited about it. On the 18th from noon to 4:00 there will be a celebration. I will be there speaking along with other community leaders. This is an important day for America and I encourage you to attend.

I would like to thank Kinsey Tiemann. She is an exceptional person to work with. She is friendly and conscientious about what she does. I hope after you graduate you'll come back to see us. You are a good student leader and after you graduate you will do very good things.

This will be Billy Clow's last meeting as the Interim Provost. We worked very closely the last year. Thank you for your support and leadership over academic programs. I speak for many of us when I say that Billy has been a critical leader in the last year.

As the Interim VP, Shannon Sutton has also been a great partner and a voice of reason in the last year. We are finishing up the search for this position and hope to find someone soon.

Welcome to Cody Cornell as our new student trustee on the board. Thank you for being here today. I look forward to your work on the board.
