PUBLIC COMMENTS

Tere North Thanked Dr. Abraham for his service. Voiced concern about the dismissal of a female candidate for President. Requested that the Board provide explanation for their choice for President.

Shakyria Bailey expressed her belief in the need for stability and it is in the students' best interest not to have a new President at this time.

Michael Lukkarinen expressed that his peers have rated Dr. Huang at or near the bottom of the candidate pool of finalists. Requested the Board provide justification for their decision.

Danielle Hughes disappointed in the choice for Dr. Huang for President. Black students felt a sense of hope under Dr. Abraham's leadership.

Briana Cross believes that black students have built rapport with Dr. Abraham and hopes that the Board has picked the best candidate.

John Sanders thanked Dr. and Nancy Abraham for their contributions, the search committee for their work, and stated the university is in a positive place as a result of Dr. Abraham's leadership.

William Thompson encouraged the university and communities to work together to help Dr. Huang be successful.

CHAIRPERSON'S COMMENTS

Chair Radosh outlined the search process, saying that the Board is united in its decision. Thanked Dr. Abraham for his work in moving the university forward. Thanked Dr. Pynes, search committee, Betty Asher and Alex Matthews. The candidate chosen, Dr. Huang, is the most competent leader and the Board is excited to bring his knowledge and experience to WIU.

Trustee Shaw welcomed Dr. Huang and thanked Dr. Abraham. Shaw is excited at this new chapter of WIU and wants to surpass WIU's former glory.

Trustee Stutz thanked Dr. Abraham and said she is incredibly impressed by Dr. Huang's qualifications and believes he is the right choice for President.

Trustee Dolieslager thanked Dr. Abraham for his leadership and that the search is concluded and encouraged everyone to believe in what is a bright future for WIU.
