President sends setter of notification to those earning the new Merit Pay award.

Professors (Unit A) submit Merit Pay Activities Document to department chair/supervisor for examination by 09/15/23 chair/supervisor and DPC chair. If professors choose not to participate in the Merit Pay system, they will submit an annual report to department chair/supervisor by this date (per Article 20.13). Department chair/supervisor and DPC chair forward their Merit Pay examination results (and signatures) to college dean or designee. 09/29/23 College dean or designee completes review of Merit Pay documents. Those professors who have earned a Merit increase shall have their 10/16/23 documents forwarded to the Provost's Office. Copies of all documents shall be sent by dean's office to applicants and departments. **Professors** developing an appeal letter to the Provost or appropriate VP have the option of directly asking any examiner for an 10/23/23 explanation of the basis for his/her alteration of the Merit Pay form. The faculty member may choose to put his/her appeal in writing to the examiner. **Examiner(s)** provides written response to professor's written request for an explanation of alterations to Merit Pay form.
