ANNUAL REPORT 2020-2021 Council on Curricular Programs and Instruction

The Council on Curricular Programs and Instruction (CCPI) met approximately every other Thursday via Zoom during the fall and spring semesters (seven meetings per semester). Members of the council included Steve Bennett, Chair (Earth, Atmospheric & GIS); Bob Intrieri, Vice-Chair (Psychology); Hadley Kaminga-Peck, Secretary (Theatre & Dance); Barry Birnbaum (Education); Courtney Blankenship (Music); Da'Veonna Campbell (SGA Representative); Niyazi Ekici (Law Enforcement and Justice Administration); Paige Goodwin (Psychology); Hoyet Hemphill (Engineering Technology); Charles Pryor (Accounting and Finance); Sebastian Syzjka (Curriculum and Instruction).

Ex-officio members of the council were Mark Mossman, Interim Associate Provost; and Donna Williams from the Registrar's Office. Additional representation from the Provost's Office was provided by Linda Prosise. Christie Hughes (Faculty Senate Office) also attended the meetings.

The bulk of the work of CCPI during 2020-2021 consisted of the first itemized duty assigned to it, which is the recommendation to the Faculty Senate for approval or disapproval of all new academic programs and courses along with changes to existing courses which affect catalog copy. CCPI considered the requests on the attached chart. Most of the curricular requests this academic year involved changes to existing courses and options. The large number of changes in existing options was a result of a required change to many teacher education programs.

Two new minors were approved by CCPI:

- 1. Conceptual Physics (Dept. of Physics)
- 2. Health Communication (Dept. of Communication)

Five new options were approved by CCPI:

- 1. B.A. in English, Creative Writing
- 2. B.A. in English, Professional Writing
- 3. B.S. Ed. in Elementary Education, ESL Education
- 4. B.S. Ed. in Elementary Education, Multilingual Education
- 5. B.S. in Fire Protection Services, Fire Medic
