Public Comments

Merrill Cole

Voiced concerns that budget reductions will harm students and the WIU community.

Review of Michelle Howes many services above her job duties.

Efficiency concerns listed include giving more work then can be reasonably accomplished by employees. Depriving students of the support they need to succeed including non academic support. Using a one size fits all blanket approach. Standardizing offerings.

UPI has requested hard numbers from administration and plea for shared governance.

Edward Woell

Review of history, then background wIth WIU.

Review of how the past shapes the here and now.

Over the past fifteen years, undergraduate enrollment has declined, Largely due to administration's choices.

Additional programmatic changes are now being made by an interim administrator including the Wide scale termination of unit B and the elimination of a category of courses in the general education curriculum.

Concerned voiced with little consultation in regards to the faculty when making these decisions. Why should anyone in the faculty trust what the administration has done or trust it will benefit the institution?

Leigh Fisler

Request to the Board to avoiding sweeping cuts that will directly impact departments and our students.

Review of the duties performed by the Unit B faculty members in the Psychology department that are essential to the department.

The implications of unilateral cuts across campus are as follows:

- 1) The closer or reduced enrollment of the Clinical/ Community Health MS program as a result of not having adequate faculty for supervision and content courses within hiring or retaining a minimum of 3 FTE faculty for appropriate supervision requirements.
- 2) The closer of the Specialist in School Psychology graduate program as a result of not having a minimum of 3 FTE per our national accreditation requirements.
- 3) The closer or reduced enrollment of the BS in Psychology program at the QC campus without sufficient faculty to sustain the current courses required for the degree.
- 4). The closer of the community serving Western Autism Center of Excellence and reduced service and clinical supervision for the Speech Language Hearing Clinic.

Amy Louck Davis

A Unit B faculty in WIU's Psychology Department (Macomb) in the graduate programs for Clinical/Community Mental Health (C/CMH) and School Psychology, and the undergraduate Forensic Psychology major.

Review of services provided in her role.

Without this position, the C/CMH and School Psychology graduate programs would be so crippled they could not function to provide the education and training of the currently enrolled students.

Programs will not continue to operate and WIU would risk losing two highly successful, accredited graduate programs.

Voiced concern that the remaining Unit A faculty would be insufficient to maintain the C/CMH and School Psychology graduate programs due to lacking skills in the remaining faculty and too few faculty to fulfill the accreditation and program requirements.

Peter Cole

Voiced concern in the changes to General Education with lack of input, consultation, and shared governance from the faculty.

Question raised as to why all non-union WIU employees were granted significant raises a few months ago if there is a budget concern.

Request to the BOT to not make such drastic changes in a manner of weeks that could harm WIU for many years.

Craig Tollini

Two suggestions posted to the Board:

1) Increased communication between all members of the university community.

Examples given of lack of communication when the past two policies had changed.

Suggestion to share all policies with all affected personnel and answer questions about them, similar to what Interim Provost Mossman did.

Increased communication is necessary to reduce (or at least address) rumors and to ensure the policies are fully understood. Increased communication can also help with morale, in part by demonstrating that everyone is valued enough to be informed.

2) Be cautious about making decisions quickly.

The Board has tasked administrators with taking action. Bad decisions can be made quickly. Examples given, in regards to the two policies, better policy could have been created if more input was sought.

A good number of faculty and staff members would support some version of most policies. Administrators can find faculty and staff who will work with them to solve problems and make decisions, but there needs to be open and honest communication (on all sides) for that to happen.

Current Unit B in the Department of Mathematics and Philosophy. Review of classes assigned and additional classes taught that were not considered overload.

Review of credentials, activities, advising, clubs and recruitment to support students and help them to learn and benefit more in the Department.

Chairperson's Remarks

Ms. Carin Stutz

- Progress is the word of the day
- Our board has recognized challenges and asked for action. The last few years we have overspent and exhausted any remaining reserves.
- I acknowledge the public comments and agree with the value of every single person that was spoken of.
- Truly wish the financial situation was different and that there was trust in the room. The money is not there.
- Today the board will approve a contract that will appoint Kristi Mindrup the Interim President as of June 30, 2024. She has been serving in the role and provided exemplary leadership. The board believes she is the right person to lead the university during this time of transition. She has been tasked with making the decisions that nobody looks forward to and she understands that the magnitude, an urgency of the situation.
- At this time, the board will postpone the search for a new president. WIU is facing economic challenges that are complicated. And need to be resolved prior to the upcoming school year. Statewide, enrollment has declined and we must be disciplined in our spending. Many universities have the same challenges.
- The postponement of a search does not mean the Dr. Mindrup has been selected permanently. A search will be conducted, but it will be deferred at this time while important issues are resolved.
- Our second objective is to get a balanced budget.
- We ask for unity as the university works on its financial challenges, and we ask for support for Dr. Mindrup. We are one hundred percent behind her as she takes on this role. She will focus on the long-term viability of the University and the continued outstanding education that every student receives while here.

Edited resolution read for the honorary naming – Goldfarb Center for Performing Arts

WHEREAS, pursuant to Section VI.C.1 of the Board of Trustees Regulations, the Board of Trustees of Western Illinois University reserves the right to name all buildings belonging to the University; and

- WHEREAS, the President shall make recommendations to the Board regarding the naming of University property; and
- WHEREAS, University property may be named for notable former employees at the University; and
- WHEREAS, Dr. Alvin Goldfarb served as the 10th President of Western Illinois University, honorably and with distinction, from 2002—2011; and
- WHEREAS, Dr. Goldfarb's career as an educator, theatre historian, and administrator culminated in his presidency at Western Illinois University; and
- WHEREAS, Dr. Goldfarb, as president, initiated the study and implementation of the Center for Performing Arts as one of the many highlights of his presidency; and
- WHEREAS, the Center for Performing Arts began in 2002 and is the first state-funded building on the Macomb campus since 1974; and
- WHEREAS, the building is a LEED Certified Silver, state-of-the-art, 100,000-square foot, \$119-million-dollar iconic performance and academic building, and is currently scheduled to be completed by 2025;

THEREFORE, be it resolved that the Board of Trustees hereby names the Center for Performing Arts THE GOLDFARB CENTER FOR PERFORMING ARTS in honor of Dr. Alvin Goldfarb. BE IT FURTHER RESOLVED that the Board of Trustees directs that an appropriate ceremony be held to mark the naming of the building.
