NOTICE OF INTENT TO CLARIFY A BARGAINING UNIT BY STIPULATION

Case No. 2024-UC-0038-C

Western Illinois University and University Professionals of Illinois, Local 4100, IFT-AFT, AFL-CIO have filed a joint petition pursuant to Section 1110.160(d) of the Illinois Educational Relations Board Rules and Regulations to clarify the existing bargaining unit to include the titles of "*Admissions and Records Coordinator*," "*Admissions and Records Representative*," "*Technical Director*," "*Information Technology Support Associate*," "*Information Technology Technical Associate*" and "*Senior Photographer*." The bargaining unit is currently described as:

Included: All employees who are appointed for at least 50% or greater time in status or probationary positions in the classifications of Admission/Records Officer I; Admissions/Records Officer II; Admissions/Records Officer III; Audio-Visual Aids Technician; Audio-Visual Aids Technician II; Audio-Visual Aids Technician III; Auditorium Technical Director; Auxiliary Computer Operations Supervisor; Broadcasting Engineer; Chief Broadcasting Engineer; Broadcasting Program Assistant; Equipment Attendant; Farmer; Home Economics Staff Assistant I; Home Economics Staff Assistant II; Laboratory Animal Care Technician I; Laboratory Animal Care Technician II; Microcomputer Support Specialist I; Microcomputer Support Specialist II; Microcomputer Support Specialist III; Photographer I; Photographer II; Photographer III; Radio Station Production Supervisor; Television Production Coordinator; Training Assistant I; Information Technology Technical Associate; Television Director/Producer; Admission and Records Assistant.

Excluded: All supervisors, managerial and confidential employees as defined by the Act as well as including all short-term or extra help employees.

This Notice will be posted for a period of twenty (20) school days as defined in the Board's Rules and Regulations. Within this notice period, any party may petition the Illinois Educational Labor Relations Board to state objections to the proposed clarification.

The Illinois Educational Labor Relations Board is an agency of the State of Illinois and does not endorse any particular choice in connection with representation for purposes of collective bargaining.
