#### **Interim President**

The Interim President of Western Illinois University serves as the chief executive officer, providing leadership to the institution by promoting academic excellence, educational opportunity, personal growth, and social responsibility. Reporting to the Board of Trustees, the Interim President's responsibilities include overseeing university planning, financial management, and resource allocation to ensure the University's financial health. The Interim President serves with integrity and authenticity, and is dedicated to raising the profile of the institution, and engages with stakeholders, including students, faculty, staff, alumni, and the Macomb and Quad Cities communities. The interim president advocates for the institution, and honors and implements the university's mission while placing student access, engagement, and success at the center of all decisions, initiatives, and activities.

- Divisional Oversight Oversee divisional leaders and major initiatives within Academic Affairs, Finance and Administration, Student Success, Advancement, Alumni, and Athletics; University Communication and Marketing; Inclusion offices and initiatives; Government Relations, Internal Audit, Legal Services, and President's Office Staff.
- Institutional Advocacy and Government Relations Form alliances at the local and state level to garner support and resources. Maintain regular communication with the Governor's office and the Illinois Board of Higher Education to align institutional and state priorities. Testify and negotiate on behalf of the University at state budget hearings and partner on legislative initiatives, such as the Equitable Funding Formula, that benefit the institution, the state, and beyond.
- Financial Management Guide the institution toward a plan of fiscal sustainability and a balanced budget, while addressing short- and long-term challenges with cash flow. Stabilize finances within a critical window of time to ensure the institution's financial health due to changes in funding and student enrollment. Address structural change opportunities, adapt and align the organization, staffing, and campus spaces for long-term financial health and operational efficiency. Engage in a comprehensive capital campaign to generate major gifts and donations, and identify additional sources of institutional revenue such as grants, supplemental funding, and more.
- Strategic Planning Establish and communicate institutional priorities that align with the institution's strategic plan, including 1) Promoting an Inclusive University Community, 2) Financial Stability and Sustainability, 3) Academic Program Innovation, and 4) Expanding Areas of Growth for the institution. Create space for faculty, staff, and students to shape future planning, define the institution, and identify opportunities for the strategic plan to evolve and for the university to thrive.
- Partnerships Maintain key partnerships with community organizations and institutional partners, including the Macomb Chamber of Commerce, Macomb Area Economic Development Corporation, Quad Cities Chamber of Commerce, Renew Moline, Black Hawk College, Spoon River College, Eastern Iowa Community College, John Wood College and more.
- Athletics Represent the university on the Ohio Valley Conference Board of Presidents, and with the NCAA. In consult with the Athletic Director, engage in long term planning in response to a changing national landscape in athletics.
- University and Community Engagement Participate and speak at university and community meetings, events, games, performances, and celebrations.

#### Vice President of Quad Cities Campus Operations

Reporting to the President and serving on the Senior Leadership Team, this position serves as the administrative leader of the Quad Cities campus by overseeing strategic planning, campus operations across academic, student, and administrative affairs; and establishes and maintains connections, relationships, and communication with Quad Cities and regional community stakeholders and officials.

- Branch Campus Administration Provide leadership and university coordination for Quad Cities-based academic programs, student services, operations, and oversight of WQPT public television on Western Illinois University's campus location in Moline, IL.
- Strategic Planning Conceptualize and implement a new strategic plan for Western Illinois University's Quad Cities campus. Integrate the plan within university-wide plans, recruitment, and retention

- initiatives. Align the plan with the Illinois Board of Higher Education Strategic Plan, and community economic development goals associated with higher education.
- Campus Master Planning Align campus space allocation and space utilization to short and long-term goals within the campus master plan. Identify transition solutions to accommodate new programming and growth in between expansion phases. Assess space allocation annually for new opportunities, synergies, and efficiencies.
- Community Engagement Establish and maintain critical partnerships between Western Illinois University and community organizations, businesses, schools, and government leaders. Connect the community to Western's academic programs, research, career pathways for students, and university-generated innovation. #### **Assistant Vice President for Academic Affairs**

This position provides leadership for academic affairs at Western Illinois University's Quad Cities campus in the areas of academic planning, new program support and development, campus schedule coordination and development, and creating academic pathways for high school and community college students to both the Quad Cities and Macomb campuses.

- Academic Degree Pathways Collaborated with the University transfer office to create new academic pathways with community college partners.
- Academic Planning and Scheduling Established and coordinated predictable, student-centered general
  education inventory and schedules to increase access to course options for a bi-modal population of
  traditional and post-traditional students.
- Academic Operational Support Ensured instructional spaces, support staff, and services ensure effective
  and efficient teaching and learning environments. Supported Western's involvement with the Quad
  Cities Manufacturing Lab and the Illinois Innovation Network.
- High School Dual Enrollment In collaboration with the Associate Provost, conceptualized, developed, and implemented new dual enrollment partnerships with area high schools toward the goal of increasing student aspirations toward a 4-year degree, and increasing regional awareness and interest in Western Illinois University campuses and programs. - support for dual enrollment prospective and enrolled students by convening a coordinating group of faculty and staff from academic programs, admissions, and advising to develop and implement processes, services, and student engagement opportunities.

### Assistant Vice President for Quad Cities and Planning

This position provided leadership and supervision in the areas of student services, academic advising, technology, and instructional support services at Western Illinois University's branch campus located in the Quad Cities (Moline, IL). The position also served as the liaison for academic planning, community college partnerships, and university initiatives focused on organizational growth and physical campus expansion in the Quad Cities.

- Campus Physical Expansion Co-lead design, planning, equipment procurement, and physical relocation of programs, people, and equipment to the new campus location. Conducted and presented to architect firm mock planning analyses for Phase I, II, and III to program instructional, student, and employee spaces at the new riverfront campus. Collected faculty input on pedagogy, teaching trends, and student learning to create campus spaces that foster student learning in and out of the classroom.
- Student Services Provided leadership for Quad Cities Student Services. Established a student employee mentor program, inspired redesign of New Student Orientation to increase participation from 50 to 150 students. Established partnerships to increase student engagement on and off campus. Early registration rates consistently increased (up 17%) and maintained steady retention rates (80%) of undergraduate students by encouraging academic advisor communication with students and coordinated student-centered scheduling.
- Academic Scheduling Successfully designed and implemented student-centered block and final exam schedule that increased full-time enrollment, decreased time to degree, increased course access, and improved efficient use of facilities. Provided support and analysis to determine Quad Cities program efficiency and opportunities to expand or develop new programs.
- Academic Degree Pathways Conceptualized, implemented, and expanded community college dual enrollment program and expanded 2+2 agreements to new Iowa partners. Developed an accelerated 3-year baccalaureate degree program in recreation park and tourism administration, which immediately doubled the number of majors from 20 to 40.
- National Engagement Relocated and established the National Clearinghouse for Commuter Programs at WIU from 2012-2021. The clearinghouse provided membership with opportunities to network with colleagues across the nation, and to access and share commuter student focused research and resources.
- Fundraising Co-wrote and received a \$106,400 AmeriCorps grant to establish a new program in August 2013 at WIU-Quad Cities, participated in donor cultivation with director of development, and supported fundraising efforts of WQPT-TV through community involvement, volunteerism, and pledge drive participation. (WIU-Quad Cities holds the license for the television station.)
- *Inclusion* Infused inclusion within strategic efforts to include and create campus environments that foster student and employee success through staff professional development, inclusion-themed programming, student recruitment, and student engagement activities.

#### Director of Instructional and Administrative Services, Quad Cities Campus
