## **Enhancing Reviews and Surveillance to Eliminate Maternal Mortality (Opp. No. CDC-RFA-DP-24-0053)**

**CFDA No.:** 93.946

**Purpose:** To improve the overall availability of information on strategies for the prevention of pregnancy-related deaths and reduction of disparities in pregnancy-related mortality nationally.

**Eligibility:** Native American tribal governments and organizations; public, state, and private institutions of higher education; state, county, special district, city, or township governments; nonprofits with 501(c)(3) status with the IRS (other than institutions of higher education); small businesses; for-profit organizations (other than small businesses); public or Native American housing authorities; and independent school districts.

**Funding:** \$133,725,000; award amounts unlisted.

**Purpose:** To expand access to high-quality, comprehensive services to low-income infants, toddlers, and their families through Early Head Start-Child Care (EHS-CC) Partnerships, or through the expansion of Head Start services and/or Early Head Start services.

**Eligibility:** Native American tribal governments and organizations; public, state, and private institutions of higher education; state, county, special district, city, or township governments; nonprofits with 501(c)(3) status with the IRS (other than institutions of higher education); small businesses; for-profit organizations (other than small businesses); public or Native

American housing authorities; and independent school districts.

**Funding:** \$102,127,361; awards between \$750,000 and \$20,509,347.

## **Innovative Finance and Asset Concessions Grant Program (Opp. No. DOT-IFACGP-FY2223-01)**

**CFDA No.:** 20.945

**Purpose:** To assist eligible public entities in (1) facilitating and evaluating public-private partnerships and (2) exploring opportunities for innovative financing and delivery for eligible transportation infrastructure projects.

**Purpose:** To expand access to high-quality, comprehensive services to migrant and seasonal infants, toddlers, and their families through Early Head Start-Child Care (EHS-CC) Partnerships, or through the expansion of migrant and seasonal Head Start services.

**Eligibility:** Native American tribal governments and organizations; public, state, and private institutions of higher education; state, county, special district, city, or township governments; nonprofits with 501(c)(3) status with the IRS (other than institutions of higher education); small businesses; for-profit organizations other than small businesses; public or Native American housing authorities; and independent school districts.

**Funding:** \$14,658,024; awards starting at \$500,000.

**Funding:** \$1.5 million; awards between \$90,000 and \$100,000.

**Strengthening ICAC Technological Investigative
