Broadband Technical Assistance (Opp. No. RUS-**BTA-2024)**

Purpose: To support technical assistance activities that promote the expansion of broadband into rural

Eligibility: State, county, township, city or special district governments; public and Native American housing authorities; Native American tribal governments and organizations; small businesses; for-profit organizations other than small businesses; nonprofits with 501(c)(3) status with the IRS (other than institutions of higher education); independent school districts; and public, private or state-controlled institutions of higher education.

Funding: Total unlisted; awards between \$50,000

and \$1 million.

Community and Schools Youth Drug Prevention Program (Opp. No. O-OJJDP-2024-172193)

Purpose: To deliver substance use prevention programs in schools through partnerships with local law enforcement agencies and community coalitions.

Eligibility: For-profit organizations other than small businesses; nonprofits with or without 501(c)(3) status with the IRS (other than institutions of higher education); and public, private or state-controlled institutions of higher education.

Funding: One award expected of up to \$10 million.

Eviction Protection Grant Program (Opp. No. FR-6800-N-79)

Purpose: To provide no-cost legal assistance to lowincome tenants at risk of or subject to eviction.

Eligibility: State, county, township, city or special district governments; for-profit organizations other than small businesses; nonprofits with or without 501(c)(3) status with the IRS (other than institutions of higher education); and public, private or statecontrolled institutions of higher education.

Funding: \$40 million; awards between \$500,000 and

\$2.5 million.

Mine Health and Safety Grants (Opp. No. MSHA-2024-1)

Purpose: To prevent fatalities, diseases and injuries from mining, and secure safe and healthful working conditions for America's miners.

Eligibility: State, county, township, city or special district governments; federally recognized Native American tribal governments and organizations; and public or state-controlled institutions of higher education.

Funding: \$10,537,000; awards up to \$800,000.
